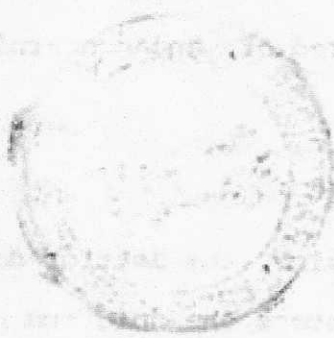

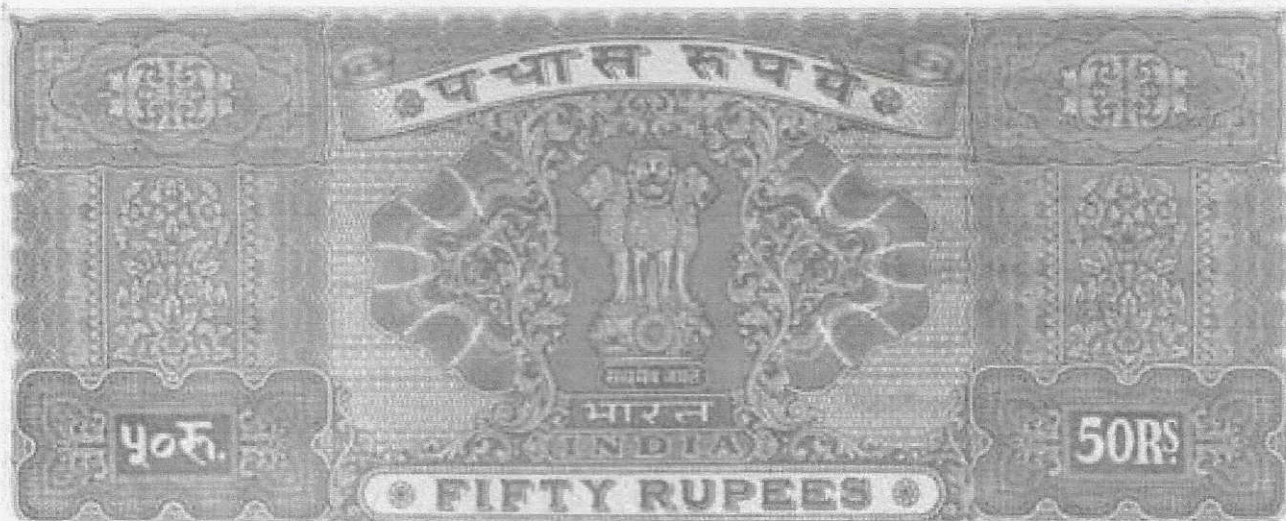

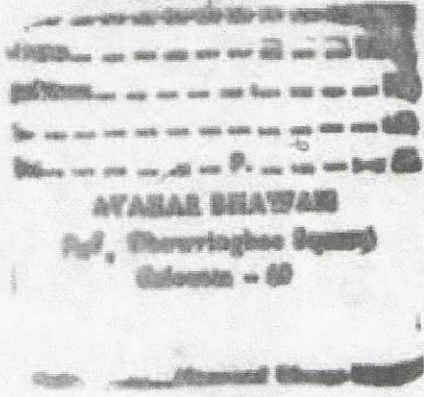

2. The Trust shall be known as "GOLDEN CHARITY TRUST" .
3. The office of the Trust shall be situated at 318, Kamalalaya Centre, 156A, Lenin Sarani,....., Calcutta - 700 013,....., which may be shifted from time to time to such other place or places within India as the Trustees may deem fit and proper at their discretion .

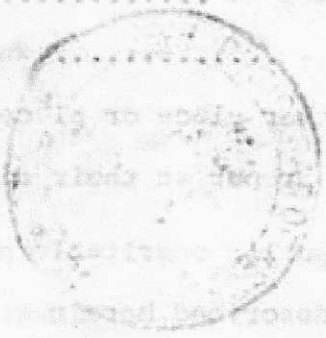

- (i) to give, provide and/or render help and assistance to, and/or implement any scheme for providing livelihood and upliftment of the poor .
- (ii) to grant scholarships, prizes and stipends to students belonging to any institution or school or college for pursuing their studies within India;
- (iii) to distribute books, periodicals etc. among poor students for their educational purposes;
- (iv) to grant aid or donation, whether in cash or in kind, to distressed and needy persons for meeting their medical expenses;
- (v) to give, provide and/or render monetary and/or other help and assistance for the relief of persons affected by natural and other calamities such as flood, fire, cyclone, storm earthquake, accident, pestilence, epidemic, drought, famines, unbearable cost of living and the like and to give donations, subscriptions or contributions to institutions, establishments, centres or persons doing relief work on such occasions and calamities .
- (vi) to help poor widows in getting their daughters married, provided such widow or widows has or have no means to meet the marriage expenses and generally to help the poor and indigent persons in the marriages of their daughters by way of cash donations or otherwise;
- (vii) to help poor, indigent and/or infirm persons who are aged but ignored by their children or relatives and have no means to maintain themselves;
- (viii) to establish and/or maintain orphanage or charitable homes for accommodating and/or helping poor and infirm or handicapped persons;
- (ix) to establish and/or maintain hospitals, charitable dispensaries or like institutions for treatment of blind and/or ailing persons having no means to bear their cost of such treatment;

- (x) to establish, maintain and grant aid to institution for development of health and physical culture;
- (xi) to establish any School or Schools, College or Colleges, Hostels, Reading Rooms, Libraries for imparting education either technical, industrial, scientific or otherwise as the Trustees shall in their uncontrolled discretion think fit and proper;
- (xii) to purchase or otherwise acquire lands or buildings and erect buildings on any land so purchased for the purpose of locating such institutions and equip such school or college and hospitals with necessary equipments, fixtures and fittings;
- (xiii) to make donation or donations for renovation or repair of any temple, mosque, gurdwara, church or other place as is notified by the Central Government in the Official Gazette to be of historic, archaeological or artistic importance or to be a place of public worship of renown throughout any State;
- (xiv) to erect and/or maintain Dharmshalas for the general public and/or construct public parks etc. for the general public;
- (xv) to construct, erect and maintain walls, tanks, bridges, bathing ghats, cremation grounds for the use of the public;
- (xvi) to grant aid, donate or contribute to other trusts or institutions having similar objects;
- (xvii) to do all other acts, matters and things for the use and benefit of the public as the Trustees may in their absolute discretion think fit and proper .

5. For the purposes of attaining and/or carrying on all or any of the objects specified in Paragraph 4 above, the Trustees shall have powers to do the following acts and deeds :-

- (a) to accept voluntary donations or contributions in cash or kind from the Settlor, the members of his family or any person or concern on such terms and conditions as the Trustees may in their absolute discretion think fit and proper;

- (b) to purchase or otherwise acquire lands or buildings and erect buildings on any land so purchased for the purposes of investment of the Trust Funds and to spend and/or utilise the rental or other incomes arising therefrom for the purposes connected with or conducive to the promotion of the objects of the Trust;
- (c) to purchase, acquire, hold, manage, improve, develop, exchange, sell, lease, mortgage, charge, dispose of, turn to account or otherwise deal with all kinds of properties movable or immovable, for the purpose connected with or conducive to the promotion of the objects of the Trust;
- (d) to borrow, lend and/or otherwise deal with the moneys or properties belonging to the Trust and to give security or take security in connection with the said dealings or acts, subject to the provisions of Sec.11(5) of the Income-tax Act, 1961 including any statutory modification thereof that might be made from time to time;
- (e) to construct, alter or keep in repair from time to time building or other immovable property belonging to the Trust;
- (f) to make, accept, endorse, discount, execute, and issue cheques, Promissory Notes, Bills of Exchange and other negotiable or transferable instruments;
- (g) to invest moneys of the Trust not immediately required for its purpose in such form or mode as prescribed in Sec.11(5) of the Income-tax Act, 1961, since amended, including any amendment that might be made from time to time; and
- (h) to amalgamate this Trust with any other trust having similar objects or to get other trust having similar objects amalgamated with this Trust with prior sanction of all the Trustees in the meeting and with prior approval of the Commissioner of Income-tax having jurisdiction, for the time being, over the Trust .

6. The number of the Trustees shall be not more than seven and not less than two .

7. The first Trustees shall be :
- (a) Sri KUMUD BHATTACHARJEE .

8. The Trustees may from time to time open and maintain in the name of the Trust a Banking Account or accounts with one or more nationalised banks and may operate on the same or authorise any one or more of them from time to time to operate on the same .
9. The objects of the Trust shall be carried out in the Union of India and the income of the Trust fund shall be spent and/or utilised for the purposes of the Trust in the Union of India .
10. The Trustees may appoint one from amongst them as the Managing Trustee for such time as they may determine and such Managing Trustee shall continue to act as such until another Managing Trustee is appointed in his place . Subject to general control and supervision of the Trustees, the Managing Trustees shall manage the Trust and its properties and funds and carry on the affairs of the Trust and shall have all necessary powers and authorities for that purpose . The Trustees may at any time co-opt any person or persons as a Trustee or Trustees of the Trust hereby constituted subject to the maximum hereby prescribed .
11. The Trustees named in Clause-7 hereinbefore shall be the first Trustees hereof and whenever any Trustee shall die, resign, refuse or become incapable or incompetent of acting or shall permanently leave India, the surviving or continuing Trustee or Trustees may appoint any other competent person or persons to be a new Trustee or new Trustees and on every such appointment, the Funds of the Trust shall be vested in a new Trustee or Trustees together with the surviving or continuing Trustee or Trustees .
12. The Trustees may appoint and nominate one of them as their Chairman for such time as may be determined by the Trustees and such Chairman shall continue to act as such until another Chairman is elected in his place . If at any meeting the Chairman is not present, the Trustees present shall choose one of them to be the Chairmen of such

meeting .

13. The surviving or continuing Trustees may act notwithstanding any vacancy in their body PROVIDED HOWEVER that if the number of Trustees shall fall below two, the minimum fixed by these presents, the Trustees shall not, except for the purpose of filling any vacancy, act so long as the number is below the said minimum .
14. A resolution in writing circulated amongst all the Trustees and passed by a majority of the Trustees shall be as valid and effectual as if it had been passed at a meeting of the Trustees duly called and convened .
15. Notice of the meeting of the Trustees and all communications may be sent to the Trustees at their addresses registered for the time being in the records of the Trust .
16. All meetings of the Trustees shall be held at such place or places as the Trustees for the time being may from time to time decide .
17. A Trustee who is unable to be present at a meeting of the Trustees may send his views on the agenda in writing and such expression of opinion shall be taken to be his vote on the matters concerned .
18. The minutes of the proceedings of every meeting of the Trustees shall be recorded in a book to be kept for that purpose and signed by the Chairman of such meeting or of the following meeting when they are read over and shall when so recorded and signed be conclusive evidence of the business and other matters transacted at such meeting
19. Three Trustees shall form a quorum for meeting of the Trustees if the number is more than five; and if five or less than five, two will form quorum . In case of difference of opinion amongst the Trustees in any matter, the opinion of the majority shall prevail and the dissenting Trustees shall be bound to join in the act which may have to be performed by the Trustees in pursuance of such decision; PROVIDED HOWEVER that in the case of equality of votes, the Chairman shall have a casting vote .
20. The Trustees shall be entitled to frame and from time to time alter, amend and add to such rules and regulations for the purpose of

carrying out the objects of the Trust and for its proper administration as they think fit; PROVIDED HOWEVER that no alteration, amendment or addition to such rules and regulations shall be made except at a meeting at which all the Trustees are present and with the consent of the majority of the Trustees . PROVIDED FURTHER that no alteration or amendment shall be made in contravention of any of the provisions of the Income-tax Act, 1961 or the Rules or Notifications thereunder which might be in force from time to time . Any such amendment shall come into effect after obtaining approval of the Commissioner of Income-tax/the Director of Income-Tax (Exemptions) having jurisdiction over the Trust .

21. Should any of the property belonging to the Trust Fund be acquired by the Government or any other public body or bodies, the Trustees shall be entitled to withdraw the compensation allowed in respect thereof and to invest the compensation money in such manner as they shall think fit, subject to the provisions of the I.T. Act, 1961 .
22. The Trustees shall keep or cause to be kept proper books of account wherein shall be kept an account of the Trust Fund, receipts and disbursements and shall appoint a Chartered Accountant to be the auditor of the Trust Fund and shall have the accounts audited by the said auditor once at least every year . The accounts of the Trust shall be closed on the day of 31st March of every English Calendar year .
23. A Trustee shall cease to be a Trustee if he absents himself from the meeting of the Trustees for more than 12 months without sufficient reason and in such case, another Trustee shall be appointed in his place by the continuing and/or surviving Trustees .
24. Any vacancy in the office of the Trustees or the absence of any of the Trustees from town will not invalidate any act done or resolution passed by the remaining Trustees in a meeting provided there is a quorum .
25. No Trustee shall be liable for any act or omission of the other or others of them and no Trustee shall be liable for any loss of the Trust properties unless caused by his wilful neglect .

26. The Trustee or Trustees of these presents for the time being may reimburse himself or themselves and pay and discharge out of Trust Fund or moneys in their hands all expenses incurred in connection with the execution of the objects of the Trust according to the powers under these presents .
27. The Trustees shall be entitled to execute and give mutual power or powers of attorney, authorising the other or others of them to act for the person or persons so giving the power in all matters connected with the Trust .
28. The receipts granted by any one of the Trustees for any moneys, stocks, funds, securities or investments paid, delivered or transferred to the Trust in exercise of the powers hereof shall effectually release and discharge the person or persons paying, delivering or transferring the same from the liability for seeing or being bound to see to the application thereof or being answerable for the loss or misapplication thereof .
29. The Trustees may employ any person or persons to do any work connected with the Trust which the Trustees may consider necessary or expedient in connection with the management of the Fund or the assets thereof and the necessary expenses of the management and all expenses incurred by the Trustees in or about execution of the Trust, shall be debited to the Trust account .
30. Any Conveyance, Mortgage, Reconveyance, Lease or any other deeds, documents and assurances whatsoever may be signed, executed and registered by any two Trustees or more of the Trustees authorised by a resolution of the Trustees in that behalf and such Conveyance, Mortgage, Reconveyance, Lease or other deeds, documents and assurances so signed by any two or more of the Trustees shall be deemed to have been signed, executed and registered by or on behalf of all the Trustees for the time being .
31. The Trustees may at any time wind up the Fund provided all the Trustees agree to such winding up and in such a case the Trustees shall realise all securities and prepare and/or complete the accounts

of the Fund and after payment of all costs and expenses of winding up of the Fund, they shall distribute and/or donate Funds and/or assets remaining in their hands among such person, concerns or Charitable Institution or Institutions having objects similar to those of this Trust in such proportion as they may think fit and proper, subject to the limitation or restrictions imposed in this behalf by the Income-tax Act, 1961 .

32. The Trustees may delegate any of their powers to one or more Committees or Sub-Committees consisting of such person or persons from amongst themselves as they may think fit and such Committee or Sub-Committee shall function subject to such rules or directions as may be prescribed or given for the purposes by the Trustees from time to time .

33. The Trust is hereby expressly declared to be an irrevocable Trust for public charitable purposes and all the provisions of this Deed are to be construed accordingly .

34. Nothing contained in this Deed shall be deemed to authorise the Trustees to do any act which may in any way be construed as violative of or contrary to the provisions of Section 11 and/or 13 of the Income-tax Act, 1961 .

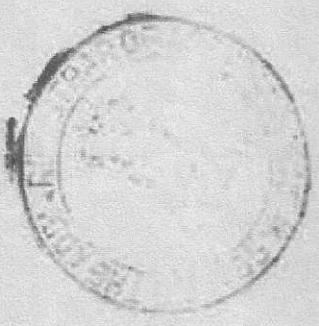

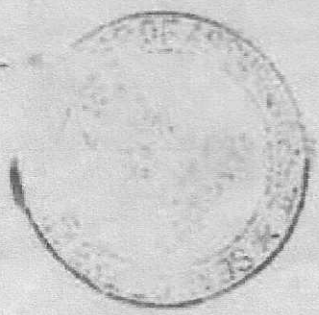

AND WHEREAS the Trustees, based on the observations made by Commissioner of Income Tax (Exemption), at their meeting held on 18th day of February, 2021 have unanimously resolved to amend / replace / delete certain clauses of the Trust Deed dated 18th day of July, 2019, with the consent of "THE SETTLOR".
